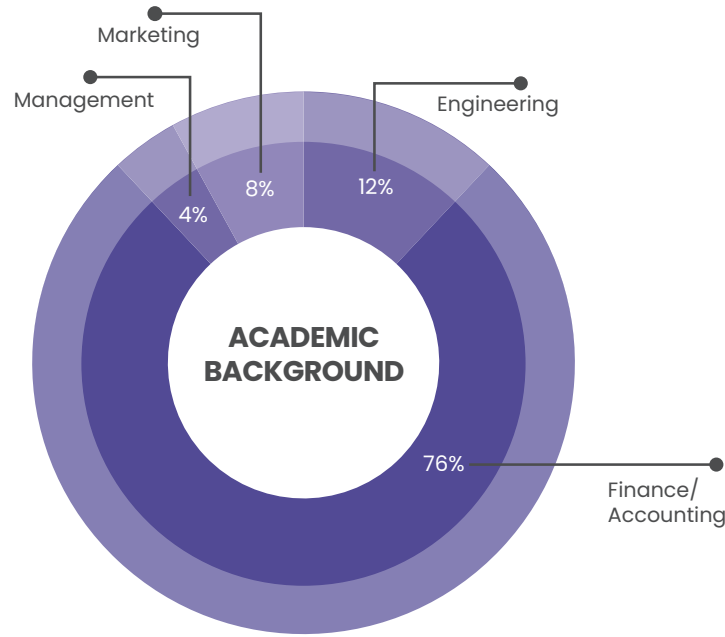

PROGRAMME STRUCTURE

The MS Financial Management weekend programme requires 1.5 years to complete 33 credit hours. Participants may be required to attend some class sessions on selected weekdays. Participants of this programme will undertake substantial academic work with continuous peer and faculty interaction between these sessions.

Students with a non-business background may have to take foundation courses before beginning the MS programme.
